I. Background

This report on Patent and Design statistics for the year 2024 has been prepared by BananalP Counsels ("BananalP") as a part of its knowledge dissemination initiatives. The report is based on the information and data available on the Indian Intellectual Property (IP) Office website and databases, and is accurate to the extent of data publication, availability, and searchability.

Over the last 10 years, BananalP has been publishing IP statistics reports on a weekly, monthly, and yearly basis on Intellepedia, the firm's IP News resource, and this report continues BananalP's ongoing contribution to the flow of knowledge in the field of intellectual property.

It may be noted that this report provides data based on calendar years as opposed to the reports of the IP Office, which are based on financial years.

II. Structure

This statistics report is structured in a two-part format. The first part of the report deals with statistics related to Patent filings, publications, examinations and grants. The second part of the report deals with Industrial designs and the statistics related to the same.



III. Part 1 – Patent Statistics

Key Highlights for the year 2024

- Patent **publications increased by** 60% from 66,493 publications in 2023 to 1,06,231 publications in 2024.
- **Examination of applications reduced** by over 36%. Only 14,705 applications were examined in 2024 compared to 23,295 applications in 2023.
- Patent grants decreased by about 15%. A total of 64,941 applications were granted in 2024.
- Total **refusals went up** slightly with 3% more applications being refused in 2024.
- Based on the Applicant's city of residence / business, Delhi contributed to the most number of patent filings (7,968 applications) followed closely by Chennai on the second position with 7,511 applications.



2024 in review


Overview of Patent statistics for the year 2024

In 2024, a total of 1,06,231 applications were published marking a 60% increase from 2023. The examination of applications appears to have however slowed down and has been on a continuous decline since 2020. An assumption on the reduced examination reports is that the patent office had accumulated a large backlog of applications which the patent office sought to clear between 2020 and 2022. The offices therefore examined more applications and issued higher numbers of examination reports in these years. A total of 64,941 applications were granted in 2024 which marks a decrease since 2023.

The image below is a graphical representation of the statistics relating to patent publications, grants, and examinations for the calendar year 2024.




City-wise patent Publication statistics for 2024

Delhi emerged as a hot spot for filings in 2024 with 7,968 patent applications being filed by Applicants residing in Delhi. Chennai followed closely with 7,511 patent applications, and Bangalore contributed 4,873 patent applications.

City-wise contribution to patent filings in 2024


IPO location / zone and technology wise examination data (2024)

Based on the location of the IP office, the most number of first examination reports (FERs) were issued by the Delhi branch followed by Chennai in the second position. Together, the offices issued 9,982 FERs out of the total 14,705 FERs issued. Based on the technology, the most number of FERs were issued for Electrical/ Electronics inventions.

Office-wise and Technology-wise FER distribution for 2024


IPO location / zone and technology wise grant data (2024)

Based on the location of the IP office, Delhi IPO granted the most number of patents in 2024, followed by Chennai and Mumbai. The highest number of grants were for inventions in the Electrical/ Electronics technologies (38,852) followed by inventions in the Mechanical field (17,452).

2020 to 2024 : What changed in five (5) years?

- Increased Patent Publications: Increased significantly from 51,205 in 2020 to 1,06,231 in 2024. Total applications published have shown a consistent increase year-on-year, with the largest jump between 2023 and 2024.
- Decreased Patent Examination: There has been a significant drop in the number of applications examined since 2020, with the lowest number recorded in 2024. Total applications examined in 2024 decreased sharply from 70,906 in 2020 to 14,705 in 2024, reflecting a drastic reduction in examination activity.
- Steady Growth in Patent Grants: There has been notable increase in the number of patents granted over the last five years, with a sharp rise starting in 2022. Grants increased markedly from 26,356 in 2020 to 64,941 in 2024, indicating an improvement in granting
- Increase in Refusals: The number of applications refused has grown steadily, indicating stricter scrutiny. Only 4,874 applications were refused in 2020 while 10,201 applications were refused in 2024, which is the highest number of refusals across the years.




City-wise patent publication statistics (2020- 2024)

Delhi appears to have reclaimed its spot as the top patent filer in 2024 after a brief two-year hiatus. Bangalore which was the top filer in 2023 and 2022 ended up at the third position in 2024 with Chennai and Delhi taking the second and first positions respectively.

City-wise contribution to patent filings (2020-2024)





The image below is a graphical representation of the data for the 5 year period since 2020 and shows the trends in office-wise FER issuance.





Technology-wise examination statistics (2020-2024)





Office-wise patent grants (2020 - 2024)



Technology-wise grants (2020-2024)




IV. Part II – Design Statistics

Industrial design registrations increased in 2024 by 26%. A total of 38,633 designs were registered in 2024. Compared to the registrations in 2020, this reflects a remarkable increase by over 165%.

Moving forward, prioritizing resources for examination, streamlining processes, and leveraging technology could enhance the system's efficiency and ensure its alignment with global best practices. Such measures will further bolster India's reputation as a competitive and innovation-driven economy.
